0621340 B.C. Ltd. (the "Company") effectively ceased operations when it sold the Nita Lake Lodge and related assets, in Whistler, BC, in March, 2010. The Company eventually assigned itself into bankruptcy on March 1, 2012 and G. Powroznik Group Inc. was named Bankruptcy Trustee.

Subsequently, the Company filed a Proposal to its creditors, under S.50 of the Bankruptcy & Insolvency Act, and on October 4, 2012, G. Powroznik Group Inc. was confirmed the Proposal Trustee by the Office of the Superintendent of Bankruptcy (the "Proposal Trustee"). A key term of the Proposal is the provision of a total of \$7,700 by a third party for the settlement of all proven unsecured claims.

Creditors with proven unsecured claims from the matter of the Bankruptcy of the Company If the amount of your claim on the attached creditor list is the same as in the creditor list in the bankruptcy, you are not required to provide any further information to the Trustee. If you would like to vote at the first meeting of creditors and are not attending, please fill in the Form 36 proxy form and return it to the Trustee prior to the first meeting of Creditors, on October 22, 2012.

If the amount of your claim on the attached creditor list has changed from your previous proof of claim form admitted during the bankruptcy, please fill out a new proof of claim (Form 31) and return it to the Proposal Trustee for admittance.
