TAKE NOTICE that an application will be made by the Applicant to Mr. Justice Grauer in chambers at the courthouse at 800 Smithe Street, Vancouver, British Columbia on Friday, September 28, 2018 at 10:00 a.m. for the following orders:

- 1. Approving the distribution of the Trust Funds and Holdback collected under the Trust Claim Settlement Program, subject to:
  - a) the passing of accounts of the Claims Administrator and the Trustee and their counsel; and
  - b) the discharge of the Claims Administrator and the Trustee in their respective mandates.
- 2. Authorizing the Claims Administrator to pay into Court any balance of Trust and Lien Funds that remain in the Claims Administrator's possession 200 days:
  - a) after payments are sent to Trust and Lien Claimants and they are not cashed or otherwise claimed by that date; or
  - b) after reasonable attempts are made by the Claims Administrator to locate any Claimants whose addresses are unknown.
