Notice and Statement of the Receiver (Subsections 245(1) and 246(1) of the Act)

The Receiver gives notice and declares that:

1. On the 9<sup>th</sup> day of June, 2010, G. Powroznik Group Inc. of G-Force Group was appointed as Receiver and Manager (the "Receiver") by an Order of the Supreme Court of British Columbia pursuant to Section 39 of the *Law and Equity Act* RBC 1996, Chapter 253, of all the assets, undertakings and property of every nature and kind whatsoever, and wherever situate, including all proceeds thereof, of T.S. Kwon Holdings Ltd. (the "Company"). The Company was adjudged bankrupt on June 9, 2010 as well with G. Powroznik Group Inc. of G-Force Group also appointed Trustee in Bankruptcy. The known assets of the Company at June 9, 2010 were:

- 2. G. Powroznik Group Inc. had been appointed Interim Receiver of the Company on April 22, 2010 by Order of the Supreme Court of British Columbia. This appointment terminated upon appointing the Trustee in Bankruptcy.

(d) The Hotel business was closed down on April 6, 2010, when the Canada Revenue Agency seized bank accounts believed to be related to the Company, the Hotel, and its furniture and fixtures.

### (f) Unsecured Creditors

We have been advised by a senior representative of a related company that there are no available books and records. This individual has provided a list of the unsecured creditors of the Company, which is attached as Schedule "A". The invoices and statements that we have seen from many of these creditors are addressed to a name other than the Company, but appear to be for services or goods provided to 1850 Douglas Street or the Traveller's Inn Downtown. The attached Schedule may not be an all-inclusive list as additional amounts could surface in the normal course of the receivership and bankruptcy and as additional review is performed.

A formal claims process will be administered by the Trustee in Bankruptcy as part of the bankruptcy process. At this time, we estimate the secured creditors will suffer a significant shortfall and there will be no available assets for the unsecured creditors. We will update our findings in subsequent reports.

#### (g) Employee Wage Claims

In addition to the aforementioned claims, from our review of the Company's available books and records, we have determined that approximately 27 employees of a related company who performed services at the Hotel have possible wage claims totaling approximately \$28,000. The Trustee in Bankruptcy will administer a formal wage claim process through the federal Wage Earner Protection Program with respect to these former employees.

- (h) The initial plan of action of the Receiver during the receivership is as follows:
  - Secure and monitor the assets of the Company.
  - Assess the state of repair of the Hotel.
  - Assess options to maximize the values and recoveries from the assets.
  - Administer the monthly parking program at the Hotel
  - Report our findings and recommendations to the Court.
